Delinquent invoices are subject to a 1.5% per thirty {30} day finance charge. Said finance charge shall be applied retroactively to the invoice due date. All payments made on delinquent accounts apply first to finance charges. Customer shall pay collection costs of 30% of any delinquent balance due from Customer under this agreement if the account is referred to an attorney. A service charge of \$25 shall be imposed for any dishonored check. All delivery orders must satisfy the following minimum requirement: cases must total three {3} and/or a total order amount of \$150, whichever is greater. Items are subject to minimums for co-op. All QDs 10 cases or higher may be co-opped unless otherwise stated with verified legal co-op accounts. There will be a fee of \$50 assessed for any order refused without good reason. All claims for breakage and/or shortages must be noted on the invoice at the time of delivery. Returns after delivery may be subject to a 10% restocking fee.
