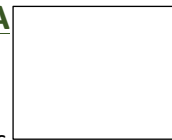

All delivery orders must satisfy the following minimum requirement: cases must total three {3} and/or a total order amount of \$150, whichever is greater. Items are subject to minimums for co-op. All QDs 10 cases or higher may be co-opped unless otherwise stated with verified legal co-op accounts. There will be a fee of \$50 assessed for any order refused without good reason. All claims for breakage and/or shortages must be noted on the invoice at the time of delivery. Returns after delivery may be subject to a 10% restocking fee.
