All QDs 10 cases or higher may be co-opped unless otherwise stated with verified legal co-op accounts. There will be a fee of \$50 assessed for any order refused without good reason. All claims for breakage and/or shortages must be noted on the invoice at the time of delivery. Returns after delivery may be subject to a 10% restocking fee.
